**Opinion**

We have audited the accompanying financial statements of **LAXYO ENERGY LIMITED** ("the company") which comprise the Balance Sheet as at March 31, 2024, and the statement of Profit and Loss, and the statement of cash flows for the year then ended and notes to the financial statements, including a summary of significant accounting policies and other explanatory information.

In our opinion and to the best of our information and according to the explanations given to us, the aforesaid financial statements give the information required by the Companies Act, 2013 ("the Act") in the manner so required and give a true and fair view in conformity with the accounting principles generally accepted in India, of the state of affairs of the Company as at March 31, 2024 and the profit and its cash flows for the year ended on that date.

**Basis for Opinion**





### **Report on Other Legal and Regulatory Requirements**

1. As required by the Companies (Auditor's Report) Order, 2020 ("the Order"), issued by the Central Government of India in terms of sub-section (11) of section 143 of the Companies Act, 2013, we give in the 'Annexure A', a statement on the matters specified in the Order, to the extent applicable.

  - (d) In our opinion, the aforesaid financial statements comply with the Accounting Standards referred to in section 133 of the Act, read with Rule 7 of the Companies (Accounts) Rules, 2014
  - (e) On the basis of written representations received from the directors as on March 31, 2024 taken on record by the Board of Directors, none of the directors is disqualified as on March 31, 2024, from being appointed as a director in terms of section 164(2) of the Act.
  - (f) Reporting on the adequacy with respect to the internal financial controls over financial reporting of the company and the operating effectiveness of such controls are not applicable to the company.
  - (g) Managerial remuneration has been paid or provided in accordance with the requisite approvals Mandated by the provisions of section 197 read with Schedule V to the Companies Act.
  - (h) According to our information and audit procedure adopted on test check basis during examination of accounting software used by the Company, we report that:
    - The accounting software used by the company for maintaining its books of accounts have a feature of recording audit trail (edit Log) facility.
    - The company has enabled audit trail (edit log) in its accounting software w.e.f. 3<sup>rd</sup> February 2024. Hence we are unable to comment for all relevant transactions recorded in the software or whether there were any instances of tampering of any data entry during the period from 01.04.2023 to 03.02.2024.
    - Further, during the course of our audit, no tampering has been observed in audit trail since the edit log facility of the software has been enabled.



- The company has preserved such audit trail for the period required under statutory provisions of the Act read with relevant Rules 11.
- (i) With respect to the other matters to be included in the Auditor's Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, in our opinion and to the best of our information and according to the explanations given to us:
- i. As per information provided to us, the company is involved in following litigations:
- The company has filed CP40 against CP27 with NCLT (formerly CLB) Mumbai against Chinara Shipping Pvt. Ltd. & its Managing Director Mr. A.K. Tripathi and Whole time Director Mr. R.S. Dube for misappropriation of fund. Laxyo Energy limited Company has debit balance of Rs. 3910974/- shown under the head of Other Non Current Assets. NCLT hearing date is 22/10/2024.
  - The company has filed case u/s 138 NI, against Adroits Projects Pvt. Ltd. for non receipt of Rs. 14.71 lacs.
  - The company has filed case u/s 420, against Chand Engineering, Gwalior for Non receipt of Rs. 10.00 lacs.
  - Laxyo Energy Ltd. procured one Raise Boring machine from Terratec Hong Kong Ltd. at a base price of USD 3,940,000/-. Upon utilizing the machine, Laxyo found manufacturing defects, which were promptly communicated to Terratec. Subsequently, both parties sought legal recourse from the Honorable Mumbai High Court where both the parties have signed a settlement agreement dated 15/12/2023. According to the said agreement, Against balance of USD 1821113.25 to be paid by LEL to Terratec, Terratec has agreed to buy Equipment and components as listed in agreement for USD 1826089.25/- after inspection and testing of equipment. Court has issued an order for the machine to be inspected by IIT Kanpur to assess its working condition. The same is under process.
- ii. The company has made provision, as required under the applicable law or accounting standards for material foreseeable losses, if any, except following:
- With Reference to above litigations amount of Rs 6382082.00/- is held as Non Current Assets and no provision is made for the foreseeable loss, if incurred. As per Management representation letter, the management are of the opinion that amount is recoverable hence not provided for.
  - The amount of Rs 16.74Lacs are shown as Disputed-doubtful debtors. No not made any provision for debtors which have been due for very long period.
  - Company has deposited Rs 18.00 lacs to GST Rajasthan under protest. No provision is made for the same.
- iii. Gratuity provision is based on management estimation and judgement however actuarial valuation is not made, in absense of which, we are unable to Comment on sufficiency of the provision.
- iv. The profit and balances of two Joint ventures have been incorporated in Financial Statements based on their unaudited books certified by management of JVs and as per books of accounts.



- v. Age wise debtors and creditors have been checked on sample basis and found
- vi. The Company does not have any long term contracts including derivative contracts in which there were any material foreseeable losses; and
- vii. There were no amounts which were required to be transferred to the Investor Education and Protection Fund by the Company
- viii. No dividend proposed in the previous year and declared by the company.

(a) Management has represented that, to the best of its knowledge and belief, other than as disclosed in the notes to the accounts, no funds have been advanced or loaned or invested (either from borrowed funds or share premium or any other sources or kind of funds) by the Company to or in any other person(s) or entity(is), including foreign entities ("Intermediaries"), with the understanding, whether recorded in writing or otherwise, that the Intermediary shall, whether, directly or indirectly lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Company ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries.

(b) Management has represented that, to the best of its knowledge and belief, other than as disclosed in the notes to the accounts, no funds have been received by the Company from any person(s) or entity(ies), including foreign entities ("Funding Parties"), with the understanding, whether recorded in writing or otherwise, that the Company shall, whether, directly or indirectly, lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Funding Party ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries, and

(c) Based on the audit procedures adopted by us, nothing has come to our notice that has caused us to believe that the representations made by the Management under sub clause (a) and (b) above, contain any material misstatement.

Based on the audit procedures performed for the purpose of reporting a true and fair view on the financial statements of the Company and taking in to consideration the information and explanations given to us and the books of account and other records examined by us in the normal course of audit, we report that:

- (i) (a) The Company has maintained proper records showing full particulars, including quantitative details and situation of Property, Plant and Equipment.  
The Company has maintained proper records showing full particulars of Intangible Assets.
- (b) The major Property, Plant and Equipment of the company have been physically verified by the management at reasonable intervals during the year and no material discrepancies were noticed on such verification.
- (c) According to the information and explanation given to us, the title deeds of the immovable properties (other than properties where the company is the lessee and the lease agreements are duly executed in favor of the lessee) are held in the name of the company.

As informed to us, any discrepancies of 10% or more in the aggregate for each class of inventory were not noticed on such verification.



- (b) The company has sanctioned working capital limits in excess of five crore rupees from HDFC Bank on the basis of security of current assets /Debtors/Work in progress etc. Quarterly returns or statements filed by the company with bank are not in agreement with the books of account of the Company. Variation is observed is due to difference in head of accounts in accounting software and presentation of financial statements as per schedule III of Companies Act 2013. The debtors provided in books are higher than statements provided to banks. We are unable to verify the ageing of Receivables in preceding quarters. As information provided to us that working capital limits from other banks are in the nature of DLOD and OD against property and there is no such requirement to file quarterly statements.

**1. Statement on Significant Accounting Policies**

**1.1 Basis of Preparation of Financial Statements :**

The Financial Statements have been prepared in accordance with the Generally Accepted Accounting Principles in India under the historical cost convention on accrual basis. The Financial Statements have been prepared to comply in all material aspects with the Accounting Standard notified under Section 211(3C) of the Companies Act, 1956, Companies (Accounting Standards) Rules, 2006, as amended and other relevant provisions of the Companies Act, 2013”

The company has maintained books of accounts in electronic mode with an audit trail feature active since 3<sup>rd</sup> February 2024 as mandated by Rule 11(g) of Companies (Audit and Auditors) Rules, 2014. The audit trail captures all changes made to accounting records with adequate preservation and security measures in place as per legal requirements.

**1.2 Use of Estimates:**

- a. The Company follows the mercantile system of accounting and recognizes income and expenditure on an accrual basis except in case of significant uncertainties. However, the company recognizes Bank Guarantee commission and LC Commission on payment basis and not on mercantile basis.
- b. Estimates and assumptions used in the preparation of the financial statements and disclosures are based upon management’s evaluation of the relevant facts and circumstances as on the date of the financial statements, which may differ from the actual results at a subsequent date.

**1.3 Property, Plant & Equipments and depreciation:**

- a. Property, Plant & Equipments are stated at their original cost of acquisitions including incidental expenses related to acquisition and installation of the concerned assets. These have been physically verified and certified. Schedule for Fixed Assets have been enclosed along with.

- b. Intangible assets:- Intangible assets are recognized when it is probable that the future economic benefits that are attributable to the asset will flow to the enterprise and the cost of the asset can be measured reliably. Such costs include any cost that is directly attributable for its intended use.

- c. Depreciation / Amortization on Assets (other than Freehold Land) :

Depreciation on the Property, Plant & Equipments is provided under straight-line method as per the rates prescribed in Schedule II to the Companies Act, 2013 so as to charge off the cost of assets to the Statement of Profit and Loss over their estimated useful life, except on the following categories of asset:

(i) Intangible assets are amortized over their useful life which is estimated to be 10 years.

- d. Impairment:

At each Balance Sheet date, the Company assesses whether there is any indication that the fixed assets with finite lives may be impaired. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment, if any. As of March 31, 2024 none of the fixed assets were considered for impairment.

**1.4 Inventories:**


Items of inventories are measured at lower of cost or NRV. The cost of inventory comprises of purchase cost , conversion cost and other costs which is required to bring inventory in saleable condition.

- i. The company engaged in contractual services relating to infrastructure development, maintenance contract, construction contract, mining and other allied activities related to various geographical locations. Physical verification of inventory on such sites at fixed intervals is not possible due to different geographical locations. The closing WIP of contractual business is based on the work progress position of ongoing contracts, on the basis of stage of completion certified by the respective site engineers and management experts.
- ii. According to site engineers, sites have materials, stores, spares and consumable items not issued in job work. Thus the same has been kept in Inventory.

**1.5 Employee Benefits:**

- a) Short terms employee benefits.

All employee benefits payable within 12 months of rendering the service are classified as short term benefits. Such benefits include salary, wages, bonus, short term compensated absences, awards, ex-gratia, performance pay etc and the same are recognized in the period in which the employee renders the related service.

- b) Provident Fund and ESIC - Benefits in the form of Provident Fund and Pension Scheme whether in pursuance of law or otherwise which are defined contributions is accounted on accrual basis and charged to profit and loss account of the year. The company is contributing to the ESIC and such contributions have been charged to P&L for the year.
- c) Gratuity- For the Gratuity Liabilities in future, Company is maintaining a fund named Laxyo Energy Employee's Group Gratuity Fund opening Credit balance of which is 2141000/-. The interest of such fund is treated as business income. Company estimates that current provision is sufficient to meet the gratuity liability hence no amount is appropriated for Gratuity during the year

#### 1.6 Investments:

As on the date of balance sheet company did not hold any investment in form of securities. Investment in Joint ventures are as mentioned in point 1.9 below.

#### 1.7 Revenue Recognition:

Revenue from sale of goods is recognized when the significant risks and rewards of ownership have been transferred to the buyer.

Revenue from services, contracts and consultancy are recognized as and when the invoices are raised as per terms and conditions of contract. Revenues are recognized net of discounts/ credit notes when collectability of the resulting receivables is reasonably assured.

Interest income is recognized on the time basis determined by the amount outstanding and the rate applicable and where no significant uncertainty as to measurability or collectability exists.

Company received amount Rs. 81.98 Lacs arising from variation in GST Rates. Out of which Rs.37.23 Lacs is w.r.t. invoices raised in FY 2022-23. The same has been recognized as revenue during the year.

#### 1.8 Construction Contracts:

- Total Contract revenue amounting to Rs. 175.29/-crs. has been recognized during the year.
- Stage of completion has been determined by the Management based on Contract costs incurred as a percentage of total estimated contract costs estimated and also considering current technical data, forecasts and estimates of net expenditure to be incurred in future including for contingencies, etc.




2. Deposits with clients, Companies & advances to suppliers as Receivable/Adjustable within 12 months so the same is treated as Current assets & shown in Note 18 as "OTHER CURRENT ASSETS."
3. The company has availed Drop Line ODs from Banks where the limit provided by the bank is decreased on regular monthly intervals. Any limit availed over and above the Drawing power that should be as on 31.03.2025 as per bank schedule should be categorized as current liability. In current year, the outstanding balance of DLOD is lower than drawing limit allowed for 31.03.2025, thus the same is categorized as Non Current Liability.
4. Current year maturity of long term loans have been bifurcated as short term liability based on EMIs due for the year after adjusting current year interest payments.
5. The company has taken certain amounts as Subcontract Deposits from Subcontractors and Mobilization Advances from Contractees. Also, capital good is purchased by the company on vendor finance/ EMI basis. The amount due for such heads have been bifurcated in current and noncurrent based on payment due in current operating cycle and terms and conditions of respective contracts. 6. The amount of Rs. 1518.44 Lacs payable to M/s Terratec is treated as non current liability as the matter is subjudiced and in settlement process.
7. A PPE (Raise Boring Machine) is treated as Non Current Asset held for sale due to the fact that company has gone into a settlement agreement with the supplier of machinery (Terratec Hongkong Ltd) where supplier is supposed to buy back the machinery. The machinery could not be used for whole year and is shifted to a another location as per settlement agreement for inspection. Therefore no depreciation has been charged on the asset and the same has not been treated as PPE.
8. During the year 2022-23, cyber fraud was committed against the company where company suffered a loss of Rs 26.79 Lacs. Rs. 2.28 Lac have been recovered from the same. It has been shown under Exceptional Item exp in Profit and Loss account.
9. In few contracts, contractee company deduct some amount from the gross revenue on account of electricity, water, cess, WCT, emd forfeiture or other deduction which is included in "Cost of material consumed" as Contract Expenses. Such deductions are in line with terms and conditions of contract.
10. Company has incurred CSR expenses of Rs 26.80 Lacs.
11. Some of the clients booked their expenses on provisional basis in their books of accounts and deducted TDS on the same even when we have not recognized such amount as revenue. The same has been included in work in progress.
